Multiplying the value factor by the total purchase price of the product determines the product's contribution toward the Project's recycled content threshold.</li> </ol>

<ul style="list-style-type: none"> <li>Cold rolled steel is cut and formed into components.</li> <li>Components are assembled using mechanical fasteners or welding.</li> <li>Components or assemblies are washed in an aqueous solution and painted with high solids paint.</li> <li>High pressure laminate is adhered to particle board using water based PVA adhesive.</li> <li>PVC edge banding is adhered to edges where required.</li> <li>Finished product is packaged in corrugated components.</li> </ul>
